2 a. Means of Program Assessment & Criteria for Success:

Principal Performance Evaluations were assessed during each observation. Mentor principals additionally submitted evaluations and final Principal Performance Evaluations. The evaluation is on a Likert scale from 1-5 and consists of 76 different areas.

2 a. Summary of Assessment Data Collected:

Visitations with the intern mentors were performed. Each mentor was required to complete a proficiency report of each intern. The proficiency report consisted of 76 proficiencies. The student was required to master a minimum of 80% of the proficiencies. A final intern evaluation was required from the mentor. The mentor was also asked to evaluate the Internship program. All students passed the Internship with a proficiency rating of 100%.

The results confirmed that the students were successful in their principal internship program.
